PRIVACY POLICY & GDPR COMPLIANCE

At The IK Foundation, we are committed to protecting your privacy and ensuring the security of your personal data. This notice explains how we collect, use, and safeguard your information in accordance with the General Data Protection Regulation (GDPR).

1. Data we collect

We may collect the following types of personal data when you visit www.ikfoundation.org and connected domains owned or managed by us.

- Contact Information: Such as your name, email address, or phone number (if voluntarily provided).
- Technical Data: Including IP addresses, browser type, and device information collected via cookies and similar technologies.
- Usage Data: Information about how you interact with our website.

2. How we use your data

We use your data to:

- Provide and improve our services.
- Respond to your inquiries or requests.
- Comply with legal obligations.
- Analyse website usage to enhance user experience.

3. Legal basis for processing

We process your data based on:

- Your consent (e.g., when you submit a form or agree to cookies).
- Our legitimate interests (e.g., improving our website or ensuring security).
- Compliance with legal obligations.

4. Data sharing and transfers

We do not sell or rent your personal data. We may share your data with:

- Service Providers: Third parties who assist us in operating our website (e.g., hosting providers).
- Legal authorities within the EU/EEA and the UK are authorised solely when mandated by law, as determined by a court ruling.

Your data may be transferred outside the EU/EEA and the UK only if adequate safeguards (e.g., Standard Contractual Clauses) are in place.

5. Your rights

Under GDPR, you have the right to:

- Access, correct, or delete your personal data.
- Object to or restrict processing.
- Withdraw consent at any time.
- Lodge a complaint with a supervisory authority.

6. Cookies and similar technologies

We use cookies and similar technologies (e.g., web beacons, pixels) to:

- Improve functionality (e.g., remembering your preferences).
- Analyse usage (e.g., tracking page visits to improve content).
- Deliver personalised content (e.g., tailoring information to your interests).

Types of cookies we use:

- Strictly Necessary Cookies: Essential for the website to function (e.g., session cookies).
- Performance Cookies: Help us analyse how visitors use the site.
- Functionality Cookies: Remember your choices (e.g., language preferences).

Your choices:

- You can accept or reject via our Cookie Consent Banner.
- You can also manage cookies through your browser settings.

Third-party cookies:

- Some cookies are placed by third-party services. These providers may process your data outside the EU/EEA and the UK. We ensure these transfers comply with GDPR.

7. Data retention

We retain your data only for as long as necessary to fulfil the purposes outlined above or as required by law.

8. Security

We implement appropriate technical and organisational measures to protect your data from unauthorised access or disclosure.
